The Potomac Valley Shetland Sheepdog Club (PVSSC) Constitution requires that this application for membership be completed and returned to the Membership Chairperson to be read and voted upon at the first Board Meeting following receipt of this application. Individuals residing at the same household may file on one application, but each applicant, if favorably voted upon by the Board, shall be deemed an individual pending member.

You must attend two regular meetings of the Club, or assist in two Club activities, or attend one meeting and assist in one Club activity within six months of the approval of this application. Family participation is encouraged. If favorably voted upon by the Board, your names(s) will be printed in the Club's newsletter as pending members (subject to the vote of the membership) and you will start to receive the newsletter, but are not entitled to vote.

After a six month evaluation period (if you have met the membership eligibility requirements), your application will be voted upon separately by the membership. You will be received into the membership after an affirmative vote of 75% of the members present at the meeting and with a quorum of 20% of the members. You are not required to attend this meeting.

If elected to membership in PVSSC, I agree to abide by the rules governing the American Kennel Club, by the regulations and requirements set up by the Constitution and By-Laws of PVSSC, and by the Code of Ethics of the Club, and will hold harmless the Club and all persons connected therewith in any capacity whatsoever from any and all liability, cost, and expense for any injury or damage to persons or property caused by any dog brought by me to the Club meetings or other event held or sponsored by the Club.
